PROGRAM ELIGIBILITY & REBATE AMOUNTS

- ◆ Property must have a water utility account with Medford Water in good standing.
- ◆ Applicant must participate in a free sprinkler checkup, in which Medford Water staff will evaluate the property's landscape and irrigation system to determine eligibility for rebate. If major improvement within the irrigation system or landscape is needed, the improvements will need to be completed prior to rebate issuance. Approval is at the discretion of Medford Water staff.
- ◆ Submit the application, receipt, and a picture of the old controller to Medford Water, either by mail or email. You may also provide the application and receipt at the time of the sprinkler checkup and controller inspection.
- ◆ New smart controller must be inspected by Medford Water staff before rebate is issued. Controller must be properly programmed and functioning.
- ◆ For hose bib smart controllers, ONLY two controllers per property are eligible for the rebate.
- ◆ Rebate applies only to the installation of WaterSense® certified smart irrigation controllers. Eligible models are identified with a WaterSense label. Verify eligibility by reviewing the list of qualifying controllers and additional required equipment on the EPA website: www3.epa.gov/watersense/product_search.html. Controller model number(s) must match the numbers on the WaterSense list.
- ◆ Additional equipment, such as a weather station, may be required for controller to qualify. Please visit the website listed above to confirm you have all of the mandatory equipment installed.
- ◆ Rebates will not be given on pre-existing controllers and/or equipment. Rebate will only be given for replacement of existing (non-WaterSense labeled) irrigation controller(s) or installation of new smart irrigation controller(s) where controller(s) had not already existed. Product(s) must appear on purchase receipt dated on or after July 1, 2017.
- ◆ Rebates requested by non property owners require written consent from property owner with signature.
- ◆ Allow 4 to 6 weeks for the processing of each rebate check.
