SUBJECT: Item 4.2 - Resolution 1950, Authorizing Execution of a Quitclaim Deed to Stewart

Meadows Village II, LLC, the Owner of Tax Lot 371W31D2800

**OBJECTIVE:** Board Approval

#### Issue

A Resolution is required to authorize the Chair of the Board of Water Commissioners to execute a Quitclaim Deed for an easement dedicated to Medford Water Commission that is no longer needed.

#### Discussion

During development of Stewart Meadows Village, Phase 2A waterline extension, the existing 12" water line within easement Doc. 2000-31724 was abandoned. A new 12" water line was installed along a new alignment within the future Anton Road which replaced the abandoned water line. A new Medford Water easement has been recorded (recorded on February 15, 2024, as Document No. 2024-003075) that covers the relocated Medford Water infrastructure.

Medford Water Staff recommends a Quitclaim Deed be executed by the Board Chair, releasing the prior recorded easement (recorded in Document No. 2000-31724 on August 1, 2000) relinquishing any rights Medford Water may have to the prior easement on this property.

## **Financial Impact**

There is no financial impact to Medford Water. Recording fees for the easement and the Quitclaim Deed are paid by the Owner.

# Requested Board Action

Medford Water Staff recommends approval of this Resolution, authorizing the Chair of the Board of Water Commissioners to sign the Quitclaim Deed in favor of the Owner, on behalf of the City of Medford, by and through its Board of Water Commissioners as set forth in the Quitclaim Deed attached to the Resolution.

A RESOLUTION Authorizing the Chair of the City of Medford, By and Through its Board of Water Commissioners to Execute a Quitclaim Deed Releasing All Right and Title to, and Interest in, the Entire Easement Originally Recorded as Document No. 2000-31724 on August 1, 2000.

WHEREAS, the Developer of the Stewart Meadows Village Phase 2A waterline extension project (Tax Lot 371W31D2800) at Anton Drive and West Stewart Avenue relocated a water main originally within the Easement recorded as Document No. 2000-31724; and

WHEREAS, the Developer has provided an alternate easement document that adequately covers the alignment of the relocated, new water line and said alternate easement has been recorded in Document No. 2024-003075 on February 14th, 2024; and

WHEREAS, the original Easement on said property is not required by Medford Water; and

WHEREAS, the original Easement is to be quitclaimed to remove the encumbrance on the property.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF WATER COMMISSIONERS OF THE CITY OF MEDFORD, OREGON, AS FOLLOWS:

The Chair is hereby authorized to sign the Quitclaim Deed in favor of the Owner of Tax Lot 371W31D2800, on behalf of the City of Medford, by and through its Board of Water Commissioners, as set forth in the Quitclaim Deed, a copy of which is attached as Exhibit A and by reference, made a part hereof.

The Released Easement Area is the water easement granted to The CITY OF MEDFORD, by and through its Board of Water Commissioners, recorded on August 1, 2000, as Document No. 2000-31724 of the Official Records of the County Clerk's Office of Jackson County, Oregon.

Portions of the Released Easement Area have been replaced by an easement granted to the Medford Water Commission, recorded in Document No. 2024-003075 of the Official Records of the County Clerk's Office of Jackson County, Oregon. This Quitclaim Deed shall have no effect on this replacement easement.

GRANTOR hereby agrees that the Water Easement recorded in Document No. 2000-31724 is hereby terminated, released and discharged with respect to the Released Easement Area, subject to the subsequently recorded easement (Document No. 2024-003075).

Before signing or accepting this instrument, the person transferring fee title should inquire about the person's rights, if any, under ORS 197.352. This instrument does not allow use of the property described in this instrument in violation of applicable land use laws and regulations. Before signing or accepting this instrument, the person acquiring fee title to the property should check with the appropriate city or county planning department to verify approved uses, to determine any limits on lawsuits against farming or forest practices as defined in ORS 30.930 and to inquire about the rights of neighboring property owners, if any, under ORS 197.352.

**SUBJECT:** Item 6 – Resolution 1951, Fourbit Logging Services

**OBJECTIVE:** Board Approval

### Issue

Medford Water plans to conduct a commercial timber harvest in this Fall of 2024 according to Medford Water's adopted Forest Management Plan.

### Discussion

Medford Water staff have selected approximately 100-acres of forested area near Big Butte Springs for harvest and thinning. The area is east of Big Butte Springs (see map), and is a mix of Ponderosa Pine, Douglas fir, and White fir with a minor hardwood and brush component. The site contains more pine than previously harvested stands much of which is not growing vigorously with pockets of beetle mortality. The stand needs to be thinned to improve forest health and reduce fire risk.

The harvest operation, known as the Fourbit Logging Services, will yield approximately 673 MBF, or 673,000 board feet, of timber comprised of Pine, White Fir and Douglas Fir. The primary goals of the operation will be to promote forest health and reduce fire risk while.

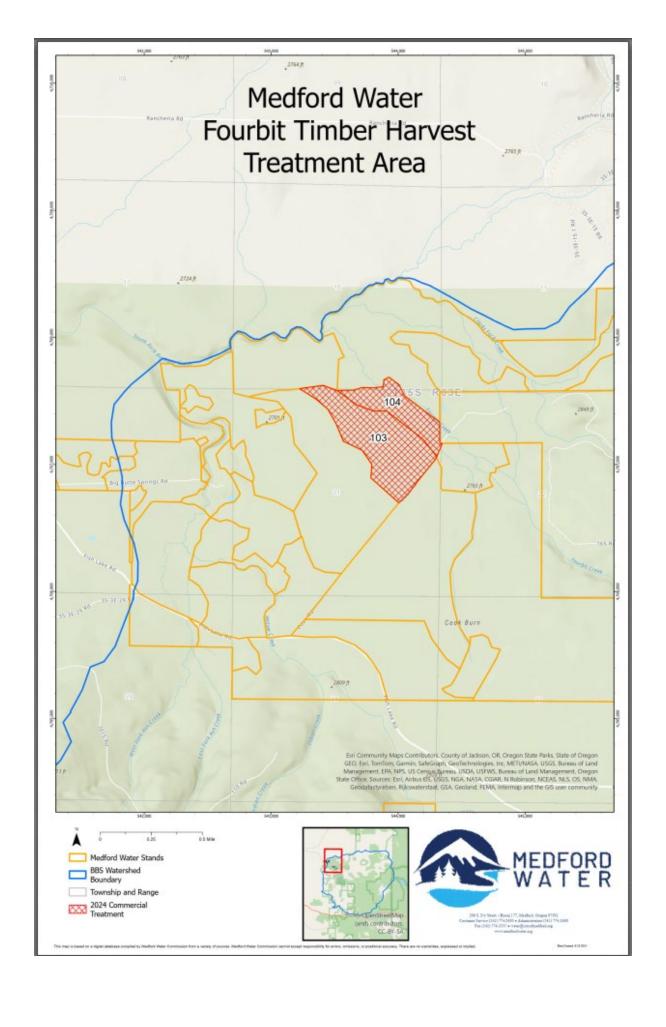
Medford Water published an invitation to bid seeking a contractor to perform commercial thinning (logging) services. Medford Water received one bid – Don Hamann, Inc. located in Butte Falls. Medford Water has received excellent quality and service from Don Hamann on past contracts and is fortunate to have them performing work again on this project.

# **Financial Impact**

The cost of logging services is included in the FY24-25 budget. While final cost of services is directly dependent on the scaled quantity of logs removed (services priced per MBF of logs harvested), based on the estimated quantity of timber a contract value of Not to Exceed (NTE) \$250,000 is anticipated to cover the services.

### **Requested Board Action**

Staff recommends awarding a NTE \$250,000 contract for Fourbit Logging Services to Don Hamann, Inc., which offered the best combination of cost (NTE \$250,000) and qualifications to successfully complete the project.

WHEREAS, Medford Water plans to conduct a commercial timber harvest in the fall of 2024 according to Medford Water's adopted Forest Management Plan, and have selected a 100-acre forested area near Big Butte Springs for harvest and thinning; and

WHEREAS, the primary goals of the harvest operation, known as the Fourbit Timber Sale, will be to promote forest health and reduce fire risk; and

WHEREAS, the Medford Water solicited bids for Fourbit Logging Services through an Invitation to Bid process; and

WHEREAS, a Notice of Intent to Award was issued to Don Hamann, Inc. on August 8, 2024, and no protests of the award were received; and

WHEREAS, Don Hamann, Inc. is qualified and agreeable to render the services specified in the aforesaid Invitation to Bid; and

WHEREAS, the value of the contract, not-to-exceed \$250,000 based on the estimated quantity of timber, exceeds the General Manager's authority;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF WATER COMMISSIONERS OF THE CITY OF MEDFORD, OREGON, AS FOLLOWS:

SECTION 1. That a contract in an amount not-to-exceed \$250,000 for Services for the Fourbit Logging Services is hereby awarded to Don Hamann, Inc.

SECTION 2. That the General Manager is hereby authorized and directed to execute said contract, payments for said contract up to \$250,000, and any contract amendments not exceeding the General Manager's purchasing authority or 25 percent of the original contract amount, on behalf of the Board of Water Commissioners, which contract is on file in the Office of the Commission and by reference made a part hereof, is hereby approved. This authorization exceeds the authority of the General Manager as defined in Section 1.02 of the Commission's Contracting & Purchasing Regulations.

Purchase Agreements for the Fourbit Timber Harvest

**OBJECTIVE:** Board Approval

### Issue

Medford Water plans to commercially thin approximately 100 forested acres near Big Butte Springs – known as the Fourbit Timber Harvest. Anticipated harvest volume is 673,000 board feet (673 mbf). A log purchasing agreement to sell the harvested logs to mills is needed.

### **Discussion**

A competitive solicitation process has been completed, inviting companies to bid for the purchase of the harvested delivered logs. Medford Water received bids from two companies shown in the following table. A notice of intent to award to Boise Cascade and Swanson Group, based on best value to Medford Water, was sent to each of the two companies on August 8, 2024.

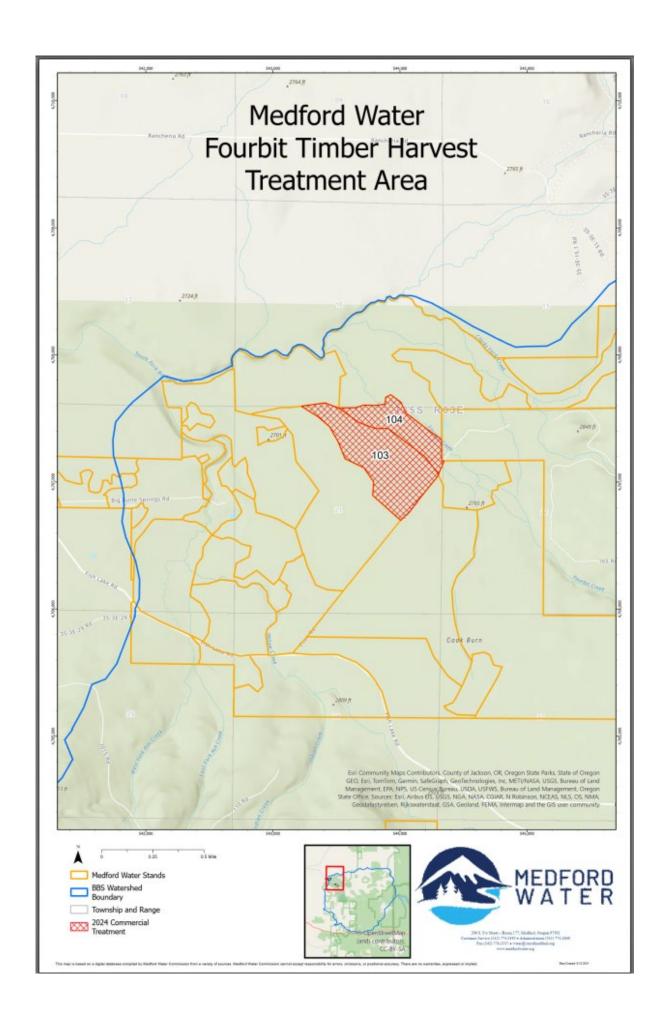

# **Financial Impact**

The anticipated revenue from these log sale agreements, is \$376,225 (actual revenues will depend on harvest volumes). The expenses associated with the harvest are estimated at \$208,699 which includes logging and hauling costs (contract pending), as well as additional slash disposal burning at approximately \$80,000. Actual total revenue for the project estimated at approximately \$85,000.

# **Requested Board Action**

Staff recommends approval of Resolution 1952, authorizing the General Manager to sign agreements with Boise Cascade and Swanson Group mills for the sale of delivered logs at the unit cost (per mbf) shown in the table above.

WHEREAS, these bidders are qualified and agreeable to purchase the timber as specified in the aforesaid Invitation to Bid; and

WHEREAS, the value of the log purchasing agreements exceeds the General Manager's authority;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF WATER COMMISSIONERS OF THE CITY OF MEDFORD, OREGON, AS FOLLOWS:

SECTION 1. That log purchase agreements for the Fourbit Timber Harvest are hereby awarded to Boise Cascade and Swanson Group.

SECTION 2. That the General Manager is hereby authorized and directed to execute said log purchase agreements up to \$500,000, which are on file in the Office of Medford Water Commission and by reference made a part hereof, is hereby approved. This authorization exceeds the authority of the General Manager as defined in Section 1.02 of the Contracting & Purchasing Regulations.

Design Services

**OBJECTIVE**: Board Approval

#### Issue

Staff is pursuing consulting engineering services to design pumping upgrades for the first phase of expansion to the Martin Control Station (CS).

#### Discussion

The Distribution System Resiliency Backbone evaluation identified Martin Control Station (CS) as the best option for a primary resilient pump station in the resilient backbone. Additional evaluation of Martin CS was performed in early 2023 which confirmed the designation of the station as a resilient pump station. This work also evaluated suitability at each of the three control stations for the addition of an inline turbine for power generation. The power generation portion of the evaluation included grant funding thru Energy Trust of Oregon in the amount of \$64,556.55.

Moving forward, the project that is the focus of the engineering design services contemplated in the Resolution before the Board today has the following focus:

- Martin Control Station 7MGD upgrade expansion to pumping, electrical upgrades, and backup power
- Conrad Control Station and Martin Control Station backup power recommendations and pump recommendations

Evaluation of the three control stations as a group is important as the three work in conjunction to deliver water from the Duff Water Treatment Plant to the Gravity Pressure Zone.

In May, Medford Water issued an RFP for consulting services to provide engineering support for this work. A selection committee of 6 individuals, including members of Operations and Engineering, reviewed and scored the 3 proposals which were received. The outcome of scoring and interviews were as follows:

- 1. RH2 Engineering
- 2. West Yost Associates
- 3. Black & Veatch

A Notice of Intent to Award the design consulting contract to RH2 Engineering was issued on August 6, 2024, and there have been no protests. Staff supports award of the contract to RH2 Engineering.

## **Financial Impact**

The contract amount being requested under this Resolution will take the project thru preliminary design (approximately 30% design). Upon completion of this work, we will be able to better identify the scope and fee necessary to take the project to 100% design and thru the construction period. At that time, we will return to the Board for an amendment to the contract amount to complete that work.

This project is included in the group of projects comprising the BRIC Grant request for which Medford Water is currently under consideration. Within that \$34.8M funding request, this project represents a potential Federal contribution of approximately \$2.3M.

This project will span multiple fiscal years. Preliminary design is expected to be completed by Q3 of the current fiscal year FY24-25. The FY24-25 CIP budget for this project is \$329,000. Additional project costs have been forecasted and accounted for in subsequent years of the 10yr CIP budget.

Completion of this phase of work will allow us to both better estimate construction costs and allow time to gain clarity on the status of our BRIC Grant request before proceeding with final design and construction. This will allow for recalibration of the project within the 10-yr CIP if needed.

### **Requested Board Action**

Staff recommends approval of this Resolution, authorizing the General Manager to execute a Contract with RH2 Engineering for the Martin Control Station 7 MGD Upgrade Design Services in the amount of \$155,439.

WHEREAS, Medford Water solicited proposals for the Martin Control Station 7 MGD Upgrade Design (CIP-22-00341) through a Request for Proposals based on the Qualification Based Selection process; and

WHEREAS, RH2 Engineering, Inc. was determined to be the highest ranking proposer; and

WHEREAS, a Notice of Intent to Award was issued to RH2 Engineering, Inc. on August 6, 2024, and no protests of the award were received; and

WHEREAS, RH2 Engineering, Inc. has submitted a Scope of Work, Schedule, and Budget for the first phase (Pre-Design) of the project and is qualified and agreeable to render the services specified therein; and

WHEREAS, the initial value of the contract, for preliminary design services, is estimated at \$155,439.00 exceeds the General Manager's authority; and

WHEREAS, future amendments to the contract value are anticipated and will be brought before the Board for approval in order to complete the project thru final design and construction phase services;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF WATER COMMISSIONERS OF THE CITY OF MEDFORD, OREGON, AS FOLLOWS:

Commissioners to Execute an Amendment to the Intergovernmental Agreement (IGA) by and between Medford Water and the City of Medford for Southwest

Infrastructure Improvements.

**OBJECTIVE:** Board Approval

#### Issue

Through previous Board Resolution 1881, Medford Water entered into an Intergovernmental Agreement (IGA) with the City of Medford to deliver specific water infrastructure projects (the "Southwest Infrastructure Improvements") paid for by grant funding obtained by the City of Medford. An amendment to that IGA is necessary to clarify the construction included in the projects as well as the delivery method and estimated reimbursable costs related to work to be performed directly by Medford Water. The Medford City Council approved the amendment to the IGA by Ordinance on July 18, 2024. The Board of Water Commissioners approval by Resolution is hereby requested.

### **Discussion**

On June 7th, 2023, the Board of Water Commissioners approved Resolution No. 1881 authorizing the Chair of the Board of Water Commissioners to Execute an Intergovernmental Agreement (IGA) by and between Medford Water and the City of Medford for Southwest Infrastructure Water Improvements.

The IGA contemplates Medford Water executing the bidding and construction management of the two projects described in an agreement between the City of Medford and the State of Oregon through the Oregon Business Development Department for \$2.7M of ARPA grant funds.

This IGA allows for Medford Water to work with the City of Medford to efficiently deliver these water construction projects, funded by grant money obtained by the City, to foster development in the Southwest portion of the City of Medford.

The first project was completed in Quarter 1 of 2024 and consisted of an extension of the water main in the Southwest Pressure Zone north in Orchard Home Dr, west along Westwood Dr and north along future Fallen Leaf Ave to directly benefit the Housing Authority of Jackson County's (HAJC) "Orchard Meadows" project. The extension of this water main also benefits future redevelopment of this area of Southwest Medford.

The second project consists of extension of water main along South Stage Road from South Columbus Ave to Kings Hwy and additional water lines in the vicinity to directly benefit the MDA

Development LLC "South Stage Park Subdivision" project at the northwest corner of South Stage Rd and Kings Hwy. The location of South Stage Park necessitates water be supplied from the Southwest Pressure Zone, for which the closest tie-on location is at South Stage Rd and Columbus Ave. This water main extension will also benefit future development to the east of Kings Hwy that also must be served from the Southwest Pressure Zone. As part of the South Stage project, certain properties at the northeast corner of South Stage Rd and Columbus Ave which are currently served from the Gravity Pressure Zone and experience less than desirable water pressures will be able to be connected to the new subzone of the Southwest Pressure Zone that this water main extension will create, greatly improving their water pressure. Design of the South Stage project is nearing completion with bidding expected in Fall of 2024.

The IGA amendment clarifies the description of both projects based on the designs and clarifies the extent of work and estimated costs to Medford Water for work performed or to be performed by Medford Water crews on both projects.

Note that this will be the second amendment to the IGA. A previous amendment was executed in August of 2023 by the Medford Water General Manager and the City of Medford City Manager, which specified required ARPA contract clauses to be included in the construction contracts.

# **Financial Impact**

The proposed IGA amendment has no substantive change to the financial impact anticipated at the time of the original IGA approval.

The main financial impact to Medford Water is consideration of cashflow needs related to Medford Water contracting directly with and paying the construction contractors. The IGA requires that the City of Medford reimburse Medford Water for such amounts within 10 days after submittal by Medford Water.

The Orchard Home project has been completed, and all costs incurred by Medford Water related to the Orchard Home project have been reimbursed by the City of Medford.

For the South Stage project, Medford Water expects to incur approximately \$40,000 of surveying and design fees from the developer's engineer to design a portion of additional water line in the vicinity of South Stage and Kings Hwy, construction of which will be paid for by the City's ARPA funds. Previous costs of approximately \$24,000, which ware not reimbursed under this IGA, were incurred in FY22-23 for staff and consultant time to analyze the requirements to rezone this area of the water system. All other costs incurred by Medford Water related to the South Stage project will be reimbursed by the City of Medford.

If project costs exceed the available grant funds the developer is responsible to the City of Medford for covering those costs.

#### SECOND AMENDMENT TO INTERGOVERNMENTAL AGREEMENT

### For Southwest Infrastructure Improvements

THE AGREEMENT, hereinafter "the Contract," made and entered into on June 1, 2023, by and between the CITY OF MEDFORD, herein referred to as CITY, and MEDFORD WATER COMMISSION, hereinafter referred to as Medford Water, is amended as outlined herein. The AGREEMENT was previously amended on or around August 14, 2023 to adopt ARPA/SLFRF Required Contract Clauses. This SECOND AMENDMENT shall have an effective date the latter of the two signatures below.

The parties hereby agree to amend the AGREEMENT as follows:

For the second recital, the language struck through below is deleted and the boldface language below is inserted in its place:

- 1. Extension of approximately 1,000 feet of existing 12-inch water main north in Orchard Home Drive, west along Westwood Drive and north along Fallen Leaf Avenue;
- 2. Connect existing water mains in South Columbus Avenue and Kings Highway by installing approximately 2,300 feet of 12 inch water main pipe;
- Install approximately 375 feet of 8 inch water main pipe along Lillian Street
- 4. Install approximately 1,200 feet of 12 inch water main pipe along South Stage Road; and
- 5. Installation of approximately one (1) fire hydrant and three (3) pressure release valves;
- 1. Extension of approximately 1,000 feet of existing 12-inch water main north in Orchard Home Drive, west along Westwood Drive and north along Fallen Leaf Avenue.
- 2. Install approximately 380 feet of 8 inch water main pipe along Lillian Street
- 3. Install approximately 740 feet of 12 inch water main pipe along Kings Highway
- 4. Install approximately 3,935 feet of 12 inch water main pipe along South Stage Road
- 5. Installation of approximately seven (7) fire hydrants and one (1) pressure release valve;

For the fifth recital, the language struck through below is deleted and the boldface language below is inserted in its place:

WHEREAS, Medford Water has provided City a non-binding estimate of its project costs as \$30,000 for the South Stage portion of the project and \$15,000 for the Orchard Home/Westwood portion of the project;

WHEREAS, Medford Water has provided City a non-binding estimate of its project costs as \$375,000 for the South Stage portion of the project and \$87,000 for the Orchard Home/Westwood portion of the project;

For Section 2, the language struck through below is deleted and the boldface language below is inserted in its place:

For the all portions of the project, Medford Water may charge to the City its actual costs of inspection and testing to the project and all other Medford Water work (e.g., wet taps and wet water connections) to the project.

For all portions of the project, Medford Water may charge to the City its actual costs of inspection and testing to the project and all other Medford Water work, including wet taps, wet water connections, installation of pipe and other projects components as necessary to complete the project.

The parties hereby amend the AGREEMENT as set forth above, and the remainder of the AGREEMENT remains in full effect as previously amended.
